All charges under this section are rendered in advance concurrent with the billing cycles, monthly or quarterly and are due and payable in full when rendered. For all quantities used, the following rates apply:

<u>Residential</u>	\$8.24 per thousand gallons
<u>Non-Residential</u>	\$9.19 per thousand gallons

All metered sales bills under this rate schedule are rendered in arrears monthly or quarterly at the option of the Newport Water Department and are due and payable in full when rendered.

1. **Metered Sales – Naval Station Newport** \$5.4115 per thousand gallons
2. **Metered Sales – Portsmouth Water & Fire Dist.** \$4.3135 per thousand gallons

MISCELLANEOUS CHARGES

1. **Temporary Water Service** retail rate for water ; meter rental \$5.00 per day; Labor cost plus 75%; \$60.00 minimum charge
2. **Meter Test- 2" or less** \$65.00 in advance
3. **Meter Test- greater than 2"** Labor cost plus 75% and contractor cost plus 25%
4. **Seasonal Turn-on and Turn-off** \$40.00 during business hours; Labor cost plus 75% after business hours

MISCELLANEOUS CHARGES (cont.)

5. **Turn-on Charge** \$40.00 during business hours; Labor cost plus 75% after business hours
6. **Meter Service** Material and equip costs plus 25%; Labor cost plus 75%; \$50.00 tapping fee for new service; Police detail at costs
7. **Interest on Delinquent Accounts** 18% per annum
8. **Interim Water Bills** \$35.00 per request
9. **Laboratory Sample Testing** Material and testing charge plus 25%; Labor costs plus 75%
10. **Flow Testing** Labor costs plus 75%; \$40.00 minimum
11. **Pressure Testing** Labor costs plus 75%; \$40.00 minimum
12. **Water Service Application Fee** Residential- \$60.00
Commercial- \$100.00
13. **Statement Charge** \$2.50 per statement
15. **Photocopying** Letter or legal size- \$0.15/page
Distribution sheet- \$3.00/ plan

Private Fire Protection

For each service connected to the Newport Water Division's mains used wholly or in part to supply private fire protection appliances owned and maintained by the customer, the following charges shall apply ***per annum***:

For each connection less than 2-inch	\$22.43
For each 2-inch connection	\$93.97
For each 4-inch connection	\$326.54
For each 6-inch connection	\$762.74
For each 8-inch connection	\$1,515.09
For each 10-inch connection	\$2,646.79
For each 12-inch connection	\$4,215.28

No additional charge will be made for private fire protection appliances owned and maintained by the customer.

All bills for private fire service under this schedule are rendered in advance and are due and payable in full when rendered.

Public Fire Protection

Applicable throughout the entire territory served by the Newport Water Division for public fire protection – All bills for public fire service are rendered in advance monthly.
