

Participation BEFORE A MEETING

In addition to soliciting public input during a meeting, the City Clerk's Office also accepts comments in advance. Written comments holds the same weight as in-person comments and may be submitted either by email, hard copy, or via the City's eComment system.

HAVE YOUR VOICE HEARD

SPEAK TO A COUNCIL MEMBER

City Council members are elected to be YOUR representative. If there's an issue that matters to you, reach out directly to your Ward representative or any At-Large Councilor to share your thoughts, concerns, or ideas. COMMENT VIA E-COMMENT

Comments received via eComment is automatically sent to the Council and Staff for inclusion in the record. Comments are also available on the City's website, as well as in paper form at the meeting for public review. To learn more about eComment, please visit www.CityofNewport.com/TV

SUBMIT A LETTER OR EMAIL

Written comments via email or hard copy may be submitted to the City Clerk's Office **no later than 12 p.m.** on the day of the meeting. Please be sure to include your name and list your address in your comments.

TIP: Know Your Council

Do you know who your Ward and At-Large Councilors are? To find out, visit **Vote.RL.Gov** and click on the link to find your Councilorofficials.

The City of Newport is a City Manager/Council form of government. In addition to electing four At-Large members of the Council to represent the entire City, Newport also has three dedicated Ward Councilors elected to represent specific geographic areas of town. Upon election, the Council selects one At-Large representative to serve as Council Chair, which also carries the honorary title of Mayor.

Participation DURING A MEETING

All regular City Council meetings are held in accordance with Roberts Rules of Order, with the order of business following the agenda unless otherwise approved by the Council. Questions and concerns about specific agenda items may be offered anytime after the Chair asks for Discussion, or during advertised Public Hearings.

CITY COUNCIL AGENDA ORDER

CITIZEN'S FORUM

If there's a topic that is **NOT** listed on the agenda that you would like to address, you may do so at the start of the meeting by signing up for the **Citizens Forum**. Please note that it is not the practice of Council to respond directly to questions during this portion of the meeting.

CONSENT CALENDAR

The Consent Calendar is approved in its entirety unless the Council removes an item for discussion. Items that typically appear in this section of the agenda include license renewals, communications, and various reports and meeting minutes.

APPOINTMENTS TO BOARDS & COMMISSIONS

RESOLUTIONS

Resolutions are placed on the docket by City Councilors and are often related to formulating new policy proposals, articulating Council priorities, and issuing directives for City Staff.

ORDINANCES

Ordinances are the City's laws and require two readings before being formally adopted.

COMMUNICATIONS FROM THE CITY MANAGER

Communications from the Manager may include items ranging from Bid Awards to reports on Council requests.

PUBLIC HEARINGS are also used periodically to solicit the public's comments on various City projects or applications. During a Public Hearing:

- The Chair will open the hearing by identifying the subject.
- Public Input- The public is asked to speak for/against the issue.
- The Council will Vote to Close Public Hearing
