


Current Wards with 2020 Population— Maximum Deviation— 2.18%








Plan A - Current Wards with 2020 Census Data













Majority/Plurality Population by Blocks by Race and Ethnicity








Current Wards – Plan A Maximum Deviation – 2.18%







Plan B - Change 1 (From Ward 1 to Ward 3)






Plan B - Change 2 (From Ward 2 to Ward 1)









Plan B - Change 3 (From Ward 3 to Ward 2)













Plan C - Change 1 (From Ward 1 to Ward 3)




Plan C - Change 2 (From Ward 2 to Ward 3)









Plan C - Change 3 (From Ward 2 to Ward 1)







Summary

- Plan A No Changes and meets the criteria
- Plan B Some changes and meets the criteria the Max Deviation is similar to Plan A
- Plan C Major Changes and meets the redistricting criteria –
 the Max Deviation is very low 0.48% with Ward 1 having
 +19, Ward 2 having exactly the same as the ideal population
 and Ward 3 having -20 people as compared to the ideal
 population.
