Approval of the amendment to the Title, Preamble, Section 3 of Article III, and Section 8 of Article IX of the Rhode Island Constitution set forth below will have the effect of changing the official name of the State from "State of Rhode Island and Providence Plantations" to "State of Rhode Island"

ADDITION TO PELL ELEMENTARY AND CONSTRUCTION OF HIGH SCHOOL \$106,500,000 BONDS AND NOTES

(Local Acts 58 and 82 – Acts and Resolves of 2020)

Shall an act passed at the 2020 session of the General Assembly entitled "An act authorizing the City of Newport to issue not to exceed \$106,500,000 general obligation bonds, notes, and other evidences of indebtedness to finance all costs relating to the construction, renovation, improvement, alteration, repair, landscaping, furnishing and equipping of (1) an addition to the Claiborne Pell Elementary School, including but not limited to, classrooms and associated support space site improvements, and parking and (II) a new school facility for the William S. Rogers High School, provided that the authorization shall be reduced by the amount of certain

grants received from state bond proceeds, from the Rhode Island Department of Education or from the Rhode Island School Building Authority" be approved? Approve or Reject

Voters not registered from their actual place of residence prior to the October 4, 2020 deadline, may register at their respective city/town hall on Election Day and cast a ballot for the President and Vice President only. You must be a U.S. Citizen, a resident of Rhode Island, and at least 18 years of age on Election Day in order to register.

For the safety of fellow voters and our staff, we kindly ask that you please respect all social distancing guidelines, including face coverings, when voting in person.
