Employee is required to perform all similar or related duties. ◆ Knowledge and experience with automated CADD and GIS programs, water distribution & mgmt. software to input or extract information in support of mapping activities. ◆ Performs marking of underground utilities and excavations as required by Dig Safe and/or City. ◆ Records water main & service information; updates and maintains water & hydrant records and information. ◆ Performs basic field surveys to locate and mark water mains, water services, water service boxes and gate boxes; including the ability to use underground utility locating equipment. ◆ Provides information regarding water-related utility; calls and log calls to Dig Safe. ◆ Inspects the installation and construction of water service lines. ◆ Creates annual CCR and edits web site content. ◆ Prepares RI DOT permits and traffic plans. ◆ Aids in the development and preparation of engineering plans and specifications. ◆ Knowledge and experience with leak detection equipment (i.e. leak correlator, noise loggers, etc.) to identify and locate water leaks.
